Thank you for submitting an abridged application for financial assistance through the State Water Implementation Fund for Texas (SWIFT) program on behalf of the Palo Pinto Co MWD # 1. The abridged applications received for the current funding cycle have been prioritized according to the criteria outlined in 31 TAC §363.1304, and the Texas Water Development Board approved the prioritization on April 11, 2024.

We are pleased to extend the Palo Pinto Co MWD # 1 an invitation to submit a complete application for financial assistance through the SWIFT program. All applicants have 30 days to submit their applications. **The deadline for receipt of the complete application is 5:00pm, Central Daylight Time, on Monday, May 13, 2024.** The invited amount and type of SWIFT funding eligible to be included in the application is summarized below. This prioritization approval does not constitute a funding commitment, but indicates that the SWIFT program is estimated to have sufficient capacity for the project, contingent on the financial and technical review of the complete application.
